

## MEMORANDUM OF UNDERSTANDING

(MOU)

This Memorandum of understanding has been made executed at Madhubani on the 10<sup>th</sup> day of August 2016, (two thousand Sixteen.)(10-08-2016)

### BETWEEN

Dr. Prabhat Das Foundation, a registered NGO (Registration No. DN-405/TN-3302 Year-2006 Patna) having its registered head office at Bengali Tola (Near Hanuman Temple), Laheriasarai, Darbhanga(District Office: Thana Mod Near Nilam Cinema Hall, Madhubani) through its Secretary Shree Mukesh Kumar Jha (hereinafter called First Party)

### AND

Jagdish Nandan College, Madhubani, a constituent Unit of Lalit Narayan Mithila University established in Madhubani through the Principal of the College (hereinafter called the Second Party)

Whereas The First Party is a NGO registered under Society Registration Act and has been actively engaged in promoting education as well as games and sports, cultural activities & extension activities since 2006. It is also a charitable Institute working for social betterment.

And whereas, the Second Party, a reputed College, of Lalit Narayan Mithila University has been established to provide education and research in various branches of science and is committed to disseminating knowledge in the concerned branches.

And whereas the First Party had organized a no. of educational events in the College campus earlier and was desirous of collaborating further in the educational and sports activities and extension activities of the Second Party in



the Campus. And whereas the proposal of the First Party has been accepted by the Second Party, the Second Party as such agrees to allow the First Party of collaborate in education and sports activities and extension activities of the Second Party in its campus for which no license fee of rent shall be charged, this agreement is for mutual benefit for both the parties for upliftment of educational and academic ambience of the students in particular and society in general of the college, and its surroundings.

Now therefore, the aforesaid parties again renew here and have agreed to formalize the cooperation at the terms and conditions as mentioned hereinafter;

1. That the Dr. Prabhat Das Foundation (hereinafter referred to as Foundations) shall work for a period of three years which can be renewed further from time to time as per mutually agreed terms and conditions.
2. That during the first six months the Foundation shall function purely on probation period during which the activities of the Foundation shall be closely monitored by a the College through its Principal. The parties agree that during the probation period, the Principal of the College have full authority and power to terminate the present MOU without assigning any reason in this regard. Conversely, the First Party shall have full freedom to terminate the collaboration, if it so wishes after giving fifteen days prior notice to the Principal, Jagdish Nandan College, Madhubani.
3. That after successful functioning for six months, it will be deemed by parties that the probation period has been completed successfully and thereafter the parties shall be required to serve at least one month notice on the other party before terminating the present MOU.
4. That the Foundation, with the prior approval of the Principal, Jagdish Nandan College, Madhubani shall arrange for holding training programmes, Seminars, Conferences, Workshops, Research programmes, Projects, Quiz Contests and Sports events in the campus of Jagdish Nandan College,



Madhubani for the all round development of the students of the College especially of under privileged and weaker section.

5. That, both parties, if they so desire will jointly organize/ sponsor other educational activities in the adopted villages, as per mutual consent.
6. That, on behalf of second party the IQAC Co-ordinator will liaison and monitor the activities of the Foundation. Principal of the College will however hold informal meeting with the Foundation official on regular interval.

Both the parties have hereby agreed on above six clauses stated above and authenticate the same with their signatures as under;
